VACCINATIONS OFFERED BY CVS

For those who have yet to get vaccinated, the NALC has announced that CVS pharmacies across the country are now offering COVID-19 vaccinations. At CVS, the vaccination will come at no cost to you regardless of what health insurance plan you have, or even if you have no health insurance. You can schedule a vaccination appointment at a CVS Pharmacy near you or walk-in to receive the vaccination without making an appointment. (You should bring your insurance card or photo ID with you.) Through September 30, active letter carriers can use Employee Federal Emergency Leave (EFEL) to take off from work and get vaccinated. Members should call the union hall for assistance in making the request. Vaccinations are proven to be the most effective defense against COVID-19. Members of Branch 11 are strongly encouraged to get vaccinated!!

"RETRO" PAY AND COLA

The Postal Service informed the NALC that the compensation owed to letter carriers under the 2019-2023 agreement ratified earlier this year will be on the August 20, 2021 (pp15) payroll checks. The "retro" pay will be based on the general pay increase of November 2019 and 2020, and the Cost-of-Living Adjustments (COLA) due to career carriers for 2020 and January 2021. The payments will be based on hours worked, so it will vary for each member. It was also announced that the fourth COLA under the new agreement will be \$1,934. That is added on to the salary of the top-grade letter carrier and proportioned for every step under O. This is payable the second pay period after the release of the July 2021 index (September 17.)

SISTER COLES STILL MISSING

There has been no new revelations in the search for Branch 11 member Kierra Coles. The Charles Hayes letter carrier has been missing since October 2, 2018. The reward for any information leading to the whereabouts of Sister Coles remains at \$47,500.
